The Authorized Trader(s) shall establish a separate and unique Password and User ID, that may not be shared with any other person or entity, in order to access one designated Account ("Designated Account") and enter into Contract Transactions on behalf of the Member. A Designated Account is an Account that is accessed by one Authorized Trader to trade on behalf of the Member. Only the Authorized Trader(s) are permitted to enter into Contract Transactions on behalf of the Member, in accordance with the HedgeStreet Rules, unless HedgeStreet receives express written notification from the Member informing HedgeStreet that another Authorized Trader has been appointed or elected to act on behalf of the Member and any and all documentation required by HedgeStreet in connection with such change has been completed and submitted to HedgeStreet. The Undersigned further understand and agree that Authorized Trader(s) shall be the designated recipient(s) on behalf of the Member to receive all notices, confirmations, reports, statements and communications of every kind that relate to a Designated Account and that HedgeStreet shall have no obligation to provide such notices to any other person or party. The Authorized Trader(s) is hereby authorized and empowered to withdraw any and all monies and property from a Designated Account, from time to time, and to direct delivery or payment thereof to the U.S. financial institution registered with HedgeStreet as designated by an Authorized Trader.

The Undersigned understand and agree that the Authorized Trader(s) shall have the authority to make and enter into, on behalf of the Member, agreements relating to any of the foregoing matters and to terminate or modify the same or waive any of the provisions thereof, and to deal generally with HedgeStreet on behalf of the Member as fully and completely as if he/she alone were the sole owner of a Designated Account, all without notice to the other or any others interested in said Account.

In addition, the Undersigned understand that HedgeStreet provides an Internet check writing capability, permitting the Member to deposit funds by way of an Internet check ("e-ValuCheck") into the account of and on behalf of said Member. The Undersigned understand and agree that e-ValuCheck is similar to a physical check requiring a valid signature from the authorized signor for the Member's account at a U.S. financial institution, before allowing the withdrawal of funds from the account at the U.S. financial institution to the Account. If the Undersigned agree to permit the Authorized Trader to sign checks on behalf of the Member utilizing e-ValuCheck, the granting of such authority to the Authorized Trader(s) will be acknowledged and confirmed by one of the Undersigned initialing the following box. _____.
