3. Trust Certification

The Undersigned Trustee(s) (the "Undersigned") hereby certify that the trust agreement (the "Trust") represented herein:

- a) **Opening of a Futures Option Account:** Grants the Undersigned express permission to open a futures and options account on behalf of the Trust (the "Account");
- b) **Permitted Investments:** Permits the Trust to engage in Contract Transactions (defined below);
- c) **Designation of an "Authorized Trustee":** Permits the Undersigned to designate one trustee to act on behalf of the Trust Account as fully and completely as if he/she alone were interested in said Account, all without notice to the other trustees, including, but not limited to, the power to do the following:
 - a. Enter Contract Transactions on behalf of the Trust through the Account;
 - b. Enter into legally binding contracts separately on behalf of the Trust through the Account;
 - c. Make distributions from the Account to an account at a U.S. financial institution registered with HedgeStreet as designated by the Authorized Trustee.

The Undersigned hereby designate the Authorized Trustee named above as having the authority, on behalf of the Trust through the Account, to enter into any agreements or transactions for and/or relating to the purchase, receipt, sale and delivery (collectively "Transactions") of futures, options and other derivative instruments (collectively the "Contracts") in the Trust's Account maintained with HedgeStreet (Transactions involving Contracts are hereinafter referred to as "Contract Transactions"). Such Authorized Trustee is one of the Undersigned Trustees, having an existing fiduciary responsibility to the Trust.

The Authorized Trustee shall establish a separate and unique Password and User ID, that may not be shared with any other person or entity, in order to access the Account and enter Contract Transactions on behalf of the Trust. Only the Authorized Trustee registered with HedgeStreet is permitted to enter into Contract Transactions on behalf of the Trust, in accordance with HedgeStreet Rules, unless HedgeStreet receives express written notification from the Trust informing HedgeStreet that another Authorized Trustee has been appointed to act on behalf of the Trust and any and all documentation required by HedgeStreet in connection with such change has been completed and submitted to HedgeStreet. The Undersigned further understand and agree that the Authorized Trustee shall be the designated recipient on behalf of the Trust to receive any and all notices, confirmations, reports, account statements and communications of every kind that relate to the Trust's Account, and that HedgeStreet shall have no obligation to provide such notices to any other person or party. The Authorized Trustee is hereby authorized and empowered to withdraw any and all monies and property from the Account, from time to time, and to direct delivery or payment thereof to the account at a U.S. financial institution registered with HedgeStreet as designated by the Authorized Trustee.
